## 2013 4-H NATIONALS

15 4-H members represented Pennsylvania at the 2013 4-H National Shooting Sports Invitational last week in Grand Island Nebraska.

The Pennsylvania Teams participating in the event were .22 Rifle, Air-Rifle, Shotgun and Compound Archery. The .22 Smallbore Team composed of Nicolle Thiry and Taylor Tennant from Frazier-Simplex 4-H (Washington County), and Sarah Sroka and Hannah Rohrer from Somerset County 4-H placed second and was awarded the Silver Medal in the NRA 3-Position Match with a score of 1549. A team from Texas won first place with a score of 1552.

All four members of Team Pennsylvania placed in the top 10. Nicolle Thiry placed 3rd, Sarah Sroka placed 7th, Taylor Tennant placed 8th and Hannah Rohrer placed 9th. The Pennsylvania Air-Rifle Team composed of Morgan Duerr, Sylvia Dreistadt and Kaylee Hobgood from Frazier-Simplex placed 4th in the 40 Shot Standing Match. Morgan Duerr placed 4th in the individual standings. In Compound Archery Brendon Smith of Cambria County placed 8th in the individual archery standings.

The National Competition will be held in Grand Island, Nebraska for the next three years. 4-H members from the various 4-H Rifle Clubs throughout Pennsylvania will participate in the Penn State 4-H Achievement Days on August 7, 2013, in an attempt to qualify for a place on a Pennsylvania Team in the 2014 National Invitational.

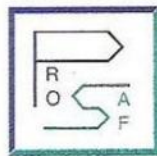

## OBAMA'S ATTACK ON CASTLE DOCTRINE BEGINS

Last year, after much delay and efforts by anti-gun, anti-second amendment legislators and lobbying by the many anti-Constitution organizations, Pennsylvania was successful in passing the Castle Doctrine Law. This law, patterned after similar laws passed in Florida and South Carolina, is referred to by many as the "Stand Your Ground Law". It essentially gives a person immunity from prosecution if he or she uses deadly force when threatened with bodily harm by another person. No longer is the victim required to flee or retreat if the threat is real.



However, recent events in both Florida and South Carolina have threatened to take these "Stand Your Ground" laws to court or to legislate to eliminate or change their self-defense intent. Events in Florida, with the Zimmerman case and the non-existent racial overtones publicized by Obama, Holder, Sharpton, Jackson and the main-stream media, are causing the Administration (Obama & Holder) to put Federal pressure on Florida officials and to request individuals to notify the FBI with any alleged misdeeds attributed to Zimmerman to retry him on any new charges possible. This Federal intervention is probably meant to change or repeal Florida's "Stand Your Ground" law or create a situation where new gun control laws can be introduced (think "Fast and Furious").

But Florida is not the only state to find difficulties in applying the "Stand Your Ground" law. I recently read about a case in South Carolina that appeared to be a cut-and-dry case of murder during a home invasion. In this case, three men broke into a home and were confronted by the homeowner. The homeowner began to fight with one of the intruders and supposedly, when it appeared as if the owner might be able to pull a gun on the intruder, the second intruder shot the owner twice, killing him.

The second intruder confessed to the shooting during court testimony. However he told the judge that he feared for his life at the time of the incident. He claimed that he was afraid of the homeowner as well as the first intruder (his cohort) who he claimed had threatened to kill him if he didn't assist in the break-in. The judge called the argument preposterous and denied a defense motion to hold a full hearing on the "Stand Your Ground" law. The defense then filed an emergency petition with the South Carolina Supreme Court seeking a stay, stopping the trial and dismissing the jury.

Here is where it gets "hairy". The SC Supreme Court does not want a hearing on the substance of the "Stand Your Ground" law. Instead it wants a hearing to determine whether the defendant can enter evidence to support his claim. The SC Supreme Court wants to see if a pretrial should be held in cases concerning "Stand Your Ground". The solicitor for the Fifth Circuit Court of Appeals feels that the issue of a pretrial in "Stand Your Ground" cases is important, but it would make it difficult to have a speedy trial where you have to have mini-trials covering such absurd situations. But the SC Supreme Court still wants to hear both the defense and prosecution's arguments. With this the defense gets another opportunity to argue for immunity from prosecution.

Homeowners, especially those with guns and those attempting to protect themselves, should pay close attention to this case. If the intruder receives immunity, just imagine what could happen in future home invasion cases or cases of self-defense. The perps could shoot first and claim immunity under "Stand Your Ground" laws. Maybe, if this logic had previously existed in the Florida case, Zimmerman would be dead and Martin would be free with immunity. What are Obama and Holder attempting to accomplish with their approach to these situations? Is the intent to protect the violent criminal, eliminate the Second Amendment and destroy the Constitution? Your thoughts???

Many items on tap for 2013, not the least of which is the 75<sup>th</sup> Anniversary of the P.R. &PA. The Board of Directors agreed that the celebration would revolve around creating more interest from our young shooting community. A presentation was made by Brian Soars from the Williamsport High School. The research he presented shows that youth introduction to the shooting sports is more likely to interest new shooters if it involves reactionary targets rather than the traditional forms of competitive shooting.

By our own numbers, and research by the National Shooting Sports Foundation, we reach only ¼ of 1% of the nation's youth with our current programs. We desperately need to develop additional approaches to better interest young shooters in our sport.

Director Julie Vaureck has been put in charge of coordinating a group of our youth shooters to develop new introductory games to be used at youth field days and related events under a P.R. &PA banner. Regional directors are also to identify clubs that can serve as regional shooting venues.

The board would like to identify facilities in each of the eight regions that can serve as high-power, small-bore, pistol, and air rifle facilities to use as both competitive and introductory ranges. We would also like to identify all available shooting sports facilities in each region to be identified on the organizations website.

Please contact your Regional Director and give them the particulars on your facility. Regional Directors are also hoping to identify P.R. &PA members to serve as advisor within their regions for all the shooting disciplines, 2<sup>nd</sup> amendment issues and publicity. See the website for information on your Regional Director and the geographical regions.

Please consider volunteering your services in one or more of these capacities.

Remember, the only way our sport will survive will be to bring in new young shooters to do that we need your help.

## STATE CHAMPIONSHIP—MILITARY RIFLE MATCH

Reade Range and Western Pa.30 cal League have scheduled the 1ST ever Pa.State Championship for the M1, 1903 Springfield & vintage military rifle match September 7, 2013. This match has been sanctioned, encouraged, and recognized as long overdue by the Pa. Rifle & Pistol Association.

We will be following the CMP format and rules for these rifles. Each rifle will have its own championship, but the winner of the 3 gun aggregate will be the PA State Champion.

For those who have never competed at Camp Perry for the National matches, this is your chance to do a similar event at the state level.

Each rifle type will be a 30 round match with an additional 5 sighting shoots, 10rds prone slow fire, 10 rds rapid from standing to prone with magazine change, 2 or 5rd loaded on empty chamber, and 10 rds standing-off hand, per rifle as per CMP rules at 200 yards. Rifles will be examined and triggers weighed prior to the match, and must be as-issued according to CMP rules. Pre-registration is necessary ,so don't delay. Please note [those who may be travelling and wish to stay overnight] should make those reservations now [as there may be a Penn State Home game that weekend and rooms may be sparse at last moment]

Here is an opportunity to shoot these fine historic rifles that saved this country with a bunch of shooters who enjoy them. These rifles are hard kicking, without match triggers and sights and just fun to shoot. Although they may not be as appealing and nor as accurate as AR-15 type rifles at longer distances, the game still comes down to who can do the 10's and X's.

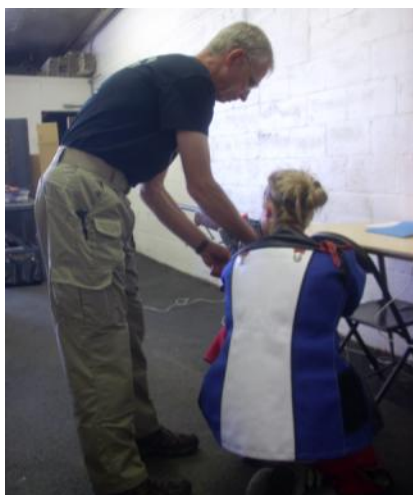

## McDONALD'S JUNE BPCR SILHOUETTE MATCH

Twenty three shooters competed in McDonald Sportsmen's Black Powder Cartridge Rifle Silhouette match on June 1, 2013. It was a hot, bright, windy day and shooters didn't have to worry about smoke hanging in front of the firing line.

Ross Arnfield lost one pig silhouette early in the day, came back with a 10 of 10 turkey score and lost one more point with the rams. He then downed three chickens offhand in gusty afternoon winds to give him a final score of 31/40, the iron sight win and the only master score shot in the iron sight category. Rudy Kovacevich took 1<sup>st</sup> place in the combined Master/AAA class with a 29/40 and Jim Radcliffe finished 2<sup>nd</sup> with 27/40. New-comer, Brian Betts won the AA/A/B class and Tom Barr took 2<sup>nd</sup> in that class.



In scope class, veteran shooter Brian Chilson, lost only one point on his prone animals and in the gusty afternoon winds, dropped five chicken silhouettes, which gave him the overall scope win and the only master score shot in the scope class with his score of 34/40. Even though Brian is a multiple iron sight and scope National Champion, he continues to work at and dedicate himself to this sport. It is not unusual to see him and his wife/spotter Debbie, practicing hard on practice day before any match they compete in. The combined Master/AAA category was won by Andy Knez with a score of 30/40 followed closely by Roger Tremba, whose score of 29/40 put him in 2<sup>nd</sup> place in that class. Richard McDonald won the AA/A/B scope class and 2<sup>nd</sup> place in that class was won by John Kyle in a coin-toss over Augie Gasper.

## McDONALD'S JULY BPCR SILHOUETTE MATCH

McDonald Sportsmen's air conditioned clubhouse was a welcome relief from the humid, 87° temperatures during their July 6, 2013 Black Powder Cartridge Rifle Silhouette match. The mild south to southwest winds kept everyone on their toes and quickly changing conditions caught many competitors. Ohioan Tim Gifford shot an excellent score of 28/40 and finished shooting on the 1st relay. West Virginian, Tom Barr, shooting on the 3rd relay, could have beaten him if he had hit all ten of his pig silhouettes, but Tom missed one pig, then a second, which secured Tim Gifford as the Iron Sight Winner. Barr's 27/40 score gave him 1<sup>st</sup> in his AA/A/B combined class and another leg on his journey to a higher classification. Dana Knezevich, firing a 26/40, was right in the mix

and took 1<sup>st</sup> Master/AAA. Jim Radcliffe and Rudy Kovacevich both tied with a 25/40. They had to have a shoot-off to determine the 2<sup>nd</sup> place in Master/AAA. In the tension filled five shot shoot-off they each hit two silhouettes. In the sudden death continuance of the shoot-off, Radcliffe raised his rifle, took aim, then lowered it and waited. Kovacevich fired and missed, and with less than 25 seconds left of the one minute time limit, Radcliffe aimed and fired. It was a hit giving him 2<sup>nd</sup> Master/AAA, dropping Kovacevich to 3<sup>rd</sup>.

Bill Simmen, the only competitor to hit four chicken silhouettes offhand in the match, handily won the Scope class with a fine score of 29/40. After a bit of trash talk, Andy Knez dethroned the "Shoot-off King", Roger Tremba in a shoot-off for 1<sup>st</sup> Master/AAA in the scope class, but Roger swore revenge at the next confrontation. Augie Gasper won the AA/A/B scope class and his spotter Roy Hosley took 2<sup>nd</sup> in that class.

## DEANNA BINNIE WINS STATE RIFLE CHAMPIONSHIP

The Pennsylvania State Outdoor 3 Position Rifle Championship, held by the Murrysville Rifle Club, saw Deanna Binnie of Hollsopple emerge on top in the two-day match.

Deanna, who won the National Junior Olympic Rifle Championship at the Olympic Training Center in Colorado Springs in April, rolled to a substantial lead on Saturday with an 1140 (out of 1200 possible points). Deanna's Conemaugh Township High School teammate, Morgan Dressick, was second at 1124 and Jack Anderson of Oil City was third with 1116.

On Sunday, Deanna extended her lead with an 1144. Jack Anderson surged into second with an 1135. Emilee Miller pulled out of the pack with an 1123 for third.

For the Championship, Deanna Binnie totaled 2284, Jack Anderson was second and High Junior with 2251, and Emilee Miller edged Cassidy Fairman for third and High Lady, 2226 to 2225.

The match was fired at 50 meters in three positions (prone, standing, and kneeling) using the same target and equipment as used in the Olympics, World Championships, and World Cup Matches.
